What is Secure Document Exchange?

Secure Document Exchange (SDX) – sometimes referred to as a portal – is a system for users to view, transfer, and share files and documents with their clients, these may be large and/or confidential and require approval by the client, individual, or company.

Key Benefits

Security of transmission

All transmissions that are sent via Secure Document Exchange are made using industry standard SSL encryption (the same as that used for online banking and payments systems) providing infinitely better security of data than standard email systems that do not generally use any form of encryption.

Ease of access

Secure Document Exchange can be accessed through any standard web browser, from any internet enabled and connected device, including mobile access via laptops, notebooks, tablets and smart phones.

Ease of use

Secure Document Exchange has been specifically designed for ease of use by leaving out many of the rarely or never used components generally found in similar packages and making the features that your company and clients use on a day to day basis simple to understand and use in practice.


No additional hardware or software

Secure Document Exchange requires no additional hardware or software and can be very quickly set up and configured.

Unlimited file size
